ABOUT THE ORGANIZATION

Bal Kalyan Sangh (BKS) in the past three decades emerged as a creative and collective response to the needs of the people so as to passionately advocate for the rights of the deprived and the most vulnerable sections of the society, be it children, women, or the homeless community. Initially, BKS was established as Bhartiya Kisan Sangh in 1978 as a farmer's movement and the objective was to educate, and empower the underprivileged community of Eastern India to achieve self-sufficiency. Gradually, while working towards this, the organization had studied the migration pattern and the related vulnerabilities that women and children face in their operational villages. Since then the organization initiated a holistic programme to address the vulnerabilities of women and children. The organization is engaged in addressing multiple vulnerabilities being faced by children, women and marginalized communities in Jharkhand. The mainstay of our work is child protection and extending support services to trafficked girls.

BKS is basically a non-government organization; working in a right based approach. People at the organization strongly believe and promote networks and alliances for advocacy of the rights of children and women. The organization has relentlessly and efficiently worked to ensure that children & women are protected and given proper care & rehabilitation. The organization has been proactive in facilitating community based organizations and strengthening them to collectively demand for their basic rights. We believe that our interventions shall lead to a society which is based on principles of non-discriminatory access and control on resources and equal opportunity to all.

Activities

Humanitarian Aid

The organization's interdependence and the frailty of our work, recognizes how a single calamity—a famine, a disease, a war—can have devastating impacts on people and the long-term development of their communities. One of the most intractable challenges to our work was combating COVID-19 thorough Humanitarian Aid. This financial year brought about major devastations all across the world due to the COVID-1 9 pandemic. The COVID-19 pandemic has now risen to a global health crisis across the globe. Jharkhand, whose 39.1% of the population lies below the poverty line and 19.6% of children under the age of five years of age are malnourished, indicates that human development of the State is low. As per the report of NITI AAYOG SDGs Baseline Report- 2018 " Iharkhand is at the bottom in terms of Ending Poverty and Zero hunger". Other than this, migration of people too is a huge challenge has to be addressed with other issues. The first wave of Covid-19 hit Iharkhand in 2020, as a result, the lockdown led to loss of jobs, no income in households, increase in poverty, malnourishment, increased exploitation against children and many other atrocities.



Bal Kalyan Sangh (BKS) as a civil society organization dealing with communities, children, illegal migration, trafficking, child protection and marginalized populations since the past three decades stood by the people of Jharkhand throughout the first wave. The goal was to mitigate the Covid-19 virus and the pandemic by ensuring basic amenities, food, medication, safe hygiene practices and awareness for children, women & families. The organization provided Humanitarian Aid to reach out to the various people by distributing cooked meals, rations and hygiene kits to the under-privileged, needy, poor and minority people etc. In addition, it also created awareness on safe practices.









During the first wave of Covid-19 in 2020, BKS came forward to provide various services to the people of the state of Jharkhand. Humanitarian Aid was provided during the pandemic because people living in and around our areas of work were going through a very difficult time. It was really pathetic to see the harsh situation of children, women and families coping during this crucial situation. People were not able to make ends meet and the families weren't able to afford even one meal for the

day. Keeping in mind the deteriorating condition of Jharkhand, BKS has come forward to reach out to the needy and the poor.

BKS reached 6333 people by providing them cooked food, 6739 people by providing them health & amp; hygiene kit and awareness about keeping themselves clean and safe along with 1089 people with grocery kits. It has targeted its project areas of Ranchi, Koderma, Dhanbad, Chaibasa, Dumka and Pakur. Total number of beneficiaries supported till now through cooked food, health services, hygiene kit and grocery kit is 14161 beneficiaries, of which 6763 at Ranchi, 2091 at Koderma, 1727 at Dhanbad, 1100 at Chaibasa, 509 at Dumka and 640 at Pakur in Jharkhand.

As a result, BKS was successful in saving the lives of the marginalized, needy and the poor who would otherwise go hungry, addressing malnutrition and aiding them for health complications, communities adopting safe practices, hygienic practices and protection of children and families from COVID-19 through awareness, campaigns and drives.



IRRC AND SRC

Bal Kalyan Sangh (BKS) effectively runs an Integrated Rehabilitation -cum-Resource Centre (IRRC) in New Delhi and a State Resource Center (SRC) in Ranchi for facilitating rescue, repatriation and rehabilitation of trafficked survivors (children, adolescent girls and women) and missing ones. This project is supported by the Jharkhand Women Development Society, Department of Women, Child and Social Security Department, Govt. of Jharkhand. The project aims to strengthen the interstate coordination mechanism for trafficked survivors, support the Government to operationalize Standard Operating Procedures for effective functioning of the State Resource Centers and ensure that comprehensive restoration protocol is followed for trafficked survivors, ensure functioning of existing Helpline number (1800-345-7055 at Ranchi & 10582 at New Delhi) for reporting of missing children, women and children in distress, serve as a Knowledge and Service Centre for children & women and generate evidence of good practices and facilitate rescue, repatriation and rehabilitation of children and women who have been trafficked or are missing or are in distress, with their families, for them to live with dignity and respect.

HIGHLIGHTED ACTIVITY

- On 19th February, 2021, 11 trafficking survivors who were rescued and brought back to Ranchi met the Hon. Smt. Joba Majhi, Minister of Social Welfare, Women and Child Development and Tourism, Jharkhand; Shri. D.K. Saxena, Special Secretary, Department of Women, Child Development and Social Security, Jharkhand. Bal Kalyan Sangh's, IRRC and SRC team met the minister and conducted a meeting where a one to one interaction was done with each of the 11 survivors. "Children who want to study will be enrolled by the government in government schools like Kasturba Gandhi Balika Vidyalaya and the others will be given training in various areas under skill development", said Hon. Smt. Joba Majhi. Shri. D. K. Saxena added, "Traffickers and employers who had lured these children from their homes and trafficked them to Delhi are to be tracked and complaints are to be filed against them."
- A consultation meeting was organized by Integrated Rehabilitation-Cum-Resource Centre, Bal Kalyan Sangh in coordination with the National Commission for Protection of Child Rights was held on the 26th of March with the Delhi State Commission for Protection of Child Rights, Child Welfare Committees and District Child Protection Officers, Delhi. The meeting was chaired by Chairperson, National Commission for Protection of Child Rights, Priyank Kanoongo to strengthen the network and partnership amongst all stakeholders for efficient coordination to work towards the best interests of children who have been rescued in Delhi. This meeting was mainly to facilitate the rescue, restoration and rehabilitation of children who have been trafficked from the state of Jharkhand and sold to various people and placement agencies in Delhi.





CHILDLINE

CHILDLINE 1098 is a service of Ministry of Women and Child Development. CHILDLINE stands for a friendly 'Didi' or a sympathetic 'Bhaiya' who is always there for vulnerable children 24 hours of the day, 365 days of the year. CHILDLINE 1098 is a phone number that spells hope for millions of children across India. It is a 24-hour a day, 365 days a year, free, emergency phone service for children in need of aid and assistance. CHILDLINE works for the protection of rights of all children aged from 0 to 18. It is an initiative for rescuing and assisting children in distress. Their special focus is on all children in need of care and protection, especially the more vulnerable sections. We not only respond to the emergency needs of children but also link them to services for their long-term care and rehabilitation. We have, till date; reached out to over three million children but also link them to relevant services for their long-term care and rehabilitation. We have, till date, connected to three million children across the nation offering them care and protection.

Bal Kalyan Sangh(BKS) works as a Nodal Organization For CHILDLINE INDIA FOUNDATION(CIF). It is implementing the 1098 service in Pakur as the Nodal organization.

OPEN SHELTER HOME, DUMKA 📕

Open Shelter Home Dumka, is a safe space for children created by BKS to attract children between the age of 0-18 age from a vulnerable situation to a safe environment. The aim to to wean these children away from their vulnerable situations through sustained interventions. These children are guided to move away from high risk and socially deviant behaviors. Children are provide opportunities for education so that they can develop their potential and talent. These children are trained and helped enhance their life-skills and reduce their vulnerabilities to exploitation so that they can be reintegrated to their families, alternative care and community. The Open Shelter here caters to all children in need of care and protection particularly beggars, street and working children, rag pickers, small vendors, street performers, orphaned, deserted, trafficked and run-away children, children of migrant population and any other vulnerable group of children.













PROJECTACTIVITIES

- Identify such children within the geographical area/location of the Open Shelters.
- Innovative child friendly approaches and outreach activities to make contact with them.
- Supplement services through Contact Locations that are established on railway platforms, crowded market areas, tourist destinations, bus stands, etc.
- Usage of techniques like music, drama, story-telling, outings and other child friendly methodologies to attract and sustain the interest of the children.
- Introduce age appropriate education; provide access to vocational training, recreation, bridge education, linkages to the National Open School Programme (NOSP), health care, counseling, etc.
- Catering to individual specific needs like substance abuse, behavioral problems and socially deviant behaviors among others.
- Providing life skills to children leading to personality enhancement, raising self-esteem, developing a positive approach to life, improving communication skills, ability to deal with trauma, reducing risk and vulnerabilities, etc.
- Providing temporary stay facilities for children; and children requiring long term care shall be referred to the nearest Shelter/Children's home.
- Functioning as a 24-hour Crisis Management Centre to receive and provide necessary assistance to children.
- Prepare Individual Care Plan for each child monitored by the DCPS from time to time.
- Maintain electronic data of each child and furnish the details to the DCPS as a part of the child tracking system.
- Recording the case history of every individual child along with the interventions required and services provided.
- Parents are attracted to the Open Shelter Home Dumka due to improved performance of In-house children in extra-curricular activities.

Sakhi

The project aims to enhance the capacity of women and identified support groups on advocacy and lobbying to address violence against women and facilitating political participation of women at all levels of governance. Violence against women needs to be seen as an issue that is based on the existing power relations, interpretation of masculinity and patriarchy that govern relationship between man and women





PROJECTACTIVITIES

- A media capacity enhancement training on reporting of women's equal rights and VAW was organized by BKS, the objective of the training was to enhance the capacity of journalists to report on Violence against women.
- Training of advocacy team members on Advocacy where the meeting of newly formed advocacy team was held in which following are the action plan made by the advocacy team as part of preparing a road map to move forward on the issues of VAW.
- 2 days training program was held for Advocates, Members of District Legal Authority (DALSA) and Sakhi didi's on equal rights for women and govt. social security schemes.
- Regional Advocacy Forum meeting was held at Ranchi. The major highlights

of the meetings conducted for discussing action plan prepared by the forum, the creation of voluntary contribution schemes on VAW, strengthening the role of media in accountability on VAW, collaboration with parliamentarians on policy and budget support for VAW, capacity building of CSOs to develop and implement locally relevant advocacy strategies on VAW, monitoring the implementation of work-plan commitments of CSOs, lobbying for increased financial support and improved political engagement of women.

- Sakhi Saheli Sammelan was organized at Swavalamban Kendra, Bijupara. The women said that in upcoming election the importance will be given to those who will work on the security of Women and girls. They will make sure that the other women of their surroundings vote to the person who promises to work on the issues of women and children. They were pretty much aware of the fact that the importance should be given to those who are likely to work for their security.
- Samudayak Champion -Through this program, the aim was to prepare women as community champions in each village so that the government-run schemes can be better implemented at the grassroots level. For this purpose, 95 women and adolescent girls of various villages of Chanho and Mandar block were trained by the various block level officials in the welfare schemes run by the government.
- Mahatma Gandhi's 151st birth anniversary was celebrated and 'Swachta hi Sewa' was organized at Swabhiman Kendra, Bijupara. To make a successful a plastic free society Bharat Abhiyan under which a rally was organized.
- A stall was put up in the Mudama Mela by BKS in which women protection and child rights were the main focused issue. Phamplets, posters, books and wall hangings on women rights, protection and empowerment were put up in the stall. Public awareness materials were displayed in the stall in the historic two-day Mudama Mela.
- A camp on Foster Care was organized by BKS in support of NCPCR. In this camp a total number of children who participated were 22women and youths were 50.
- Bharat Ki Beti Bharat Ki laxmi program was held at Swabhiman Kendra, Bijupara- Inauguration of computer centre and beautician training centre was done by Smt. Karanpreet Kaur, Guest of Honour.
- A programme layout meeting was held with the partners and Sakhi didi's.

Around 50 Sakhi didi (rural women and adolescents) and women/youth club members from various blocks of Ranchi district Chanho, Burmu, Kuru and the project staffs assembled together to acquire training on various issues related to women violence.

- A program was organized with the participation of Sakhi and Saheli of 8 villages in which they were told about Swavalamban Connect Kendra and SRC toll free no. i.e. 18003457055.
- A meeting of Sakhi and Saheli was organized at Sukurhutu village to make them aware of the Swavalamban Kendra at Burmu and New Year calendar of BKS was also distributed among them.





SWAVALAMBAN

(Livelihood training of unemployed women and vulnerable adolescent girls of Jharkhand):

Swavalamban is a project of Bal Kalyan Sangh (BKS) supported by The Embassy of the Kingdom of the Netherlands which provides free of cost skill development training program to the women and girls of Jharkhand in the age group of 18-35. The present scenario of the Jharkhand shows that most of the young girls of the interior areas are trafficked or falsely lured and taken to the metropolitan cities in search of work. The economically backward families who cannot afford the living cost of their children send their children to work in the other states to earn some money and support their family but most of the time fake placement agencies sell these children specially girls to the hotels, brothels, Massage parlours etc. The project gives a opportunity to the girls who want to earn and improve their livelihood. The project is mainly focused on the girls who are survivors of trafficking or any abuse; vulnerable girls or women who migrate from Jharkhand; women and girls of tribal families with no source of regular income; the tribal youths who are in search of livelihood; the girls lured into extremism etc. The age limit for enrolling into the

- Bharat Ki Beti Bharat Ki laxmi program was held at Swabhiman Kendra, Bijupara on-Inauguration of computer centre and beautician training centre was done by Smt. Karanpreet Kaur, Guest of Honour.
- Oath Taking Ceremony Certificate cum Oath taking ceremony of the 1st batch trainees of Security Guards conducted by Bal Kalyan Sangh on at Swabhiman Kendra, Bijupara; 2nd and 3rdbatch trainees of security guards and Housekeeping were awarded at Jharkhand Rai University Campus Namkum, Ranchi and Swabhiman Kendra, Bijupara respectively.
- The Swavalamban Kendra, Burmu was inaugurated by the President of NCPCR, the trainees were told that they need to be self-reliant; this training will help them to stay away from the issues such as of trafficking and migration.
- A One day group orientation was given to the Sakhi and Saheli members about Swavalamban Connect Kendra (SCK) and the toll free no. attached to it at Kishori Niketan, Bijupara.

BALKUNJ – BOYS HOME

Balkunj is a Child Care Institution of BKS situated at West Singhbhum (Chaibasa) particularly for boys in the age group of 6 to 18 years which got started in the month of September, 2016. The children who went missing or are footpath beggars, wanderers, child rescued from any sort of child labor, children whose parents are no more and doesn't have a place to stay are provided the facility of shelter, food, counseling, care, daily needs, education and different types of training on life skill and increasing motivation.

BAL KALYAN ASHRAM

Swavalamban is a new project of Bal Kalyan Sangh (BKS) which provides livelihood training of unemployed women and vulnerable adolescent girls of Jharkhand. It provides free of cost skill development training program to the women and girls of Jharkhand in the age group of 18-35. The project gives a opportunity to the girls who want to earn and improve their livelihood. The project is mainly focused on the girls who are survivors of trafficking or any abuse; vulnerable girls or women who migrate from Jharkhand; women and girls of tribal families with no source of regular income; the tribal youths who are in search of livelihood; the girls lured into extremism etc. The age limit for enrolling into the training programme is 18 years to 35 years with the minimum qualification needed is matric pass with reading and writing in Hindi.

Goal: Strengthen the capacity of unemployed women, survivors or victim of trafficking or abuse and vulnerable poor girls in Jharkhand to improve their livelihoods and live with dignity and self-respect.

Status: Around 24 girls have been imparted with the training of Housekeeping and Security guards.

Bal Kalyan Ashram also has two very important spaces, that is, the Mushroom Laboratory and Production Unit and the Sale Centre of Bal Kalyan Ashram.

Other Activities:

We also have have mushroom production experts who prepare seeds in the laboratory and look after the entire mushroom production process. Pickles and medicines are also prepared and sold.



RESEARCH

Bal Kalyan Sangh attains to be able to see the multitude of invisible lines within the systems that hold our lives together, or divide us. We learn to recognize the disconnects, and to help our people figure out how to reconnect the dots. We view the world through a lens of person-in-environment, that is to say, we seek to understand the context in which our people live.

The social sciences have an inherent obligation not only to keep abreast of current relevant research, but also to be competent enough to apply new treatments and insights within our practice. Research helps us assess the needs and resources of people in their environments, evaluate the effectiveness of social work services in meeting people's needs, demonstrate relative costs and benefits of social work services, advance professional education in light of changing contexts for practice and understand the impact of legislation and social policy on the people and communities we serve. So, research is important to Bal Kalyan Sangh because it helps us be effective! We have emerged as an important stakeholder to conduct research studies and surveys in Jharkhand and India, below mentioned are the research studies undertaken by BKS this year.

- A research study was conducted on 'How children getting exploited by using Online Platforms', the study aimed to understand the nuances of how the online platforms are being used for exploitation and various crimes against children and how it is impacting differently on children and families of different socio-economic background; overall objective of the study is to understand the situation pertaining to use of online platforms for various types of exploitation and the possible interventions to combat/prevent these exploitation.
- The National Commission for Protection of Child Rights (NCPCR) engaged Bal Kalyan Sangh to conduct a study on "A Study on Review of Mechanism developed in States u/s 32 of RTE Act, 2009 for grievance redressal". The study aimed to develop an understanding of the nature of Mechanism for redressal of grievances in all the 10 States (Andhra Pradesh, Bihar, Delhi, Gujarat, Maharashtra, Meghalaya, Sikkim, Karnataka, Odisha, Uttar Pradesh)

pertaining to Right to Education Act, 2009 by Quantitative and Qualitative analysis of the mechanisms developed by the States. It will include examining the nature of Complaints and its redressal process for understanding how these mechanisms helps in resolving the Child Rights issues at the earliest. As well as Examining the role of stakeholder's responsible/ accountable authorities in grievance redressal mechanism under RTE Act.

- The National Commission for Protection of Child Rights (NCPCR) awarded a study to Bal Kalyan Sangh to examine *Safety & Security of Children in Pre-metric Hostels.* This, survey was to be conducted in randomly selected hostels and it includes the observation of the Hostel with regards to the safety and Security of Children, interview with the hostel authority (warden/superintendent etc.) by the assessor and focus group discussion for children if they are available at the time or online for group discussion.
- As a part of the Samvardhan Programme, BKS in collaboration with the NCPCR conducted "A Research Study on Vulnerable Mapping of Trafficked Children and Hotspot areas (Source, Transit and Destination)in Jharkhand" to identify the vulnerable children and routes through which they are being trafficked so that we may work ahead to aware people and block the routes of traffickers to end trafficking of children. A survey was conducted an vulnerable children were identified in 6 blocks- Arki, Karra, Khunti, Murhu, Rania and Torpa of Khunti District. It was analyzed from the survey that every block has more than 600 vulnerable children whereas there were a total of 3907 vulnerable children identified all together through the collection of primary and secondary data. The maximum numbers of vulnerable children were identified from Rania. The identified children according to the data collected from these blocks were victims of Trafficking, Child Violence, Child Marriage, Child Labour, were missing, homeless, orphan, had single parent, incapable parent, seriously ill parents, are disabled, Unsafe, affected by disaster, affected by Naxal, not going to school, Child Drug addict, Malnourished, Child of drug addict Family, Child of gaming family, suffering from or suffered from Covid-19(Children returned During lockdown), Children of elderly parents, Transgender Child or have faced conviction for crime.

Workshops, Trainings and Events

- A regional workshop on Preventing Child Marriage-Post COVID-19 Lockdown Situation was organized and held on the 30th of October, 2020 virtually via Google Meet with participants and guest speakers from 6 states, namely Jharkhand, Odisha, West Bengal, Bihar, Chhattisgarh & Andaman and Nicobar.
- A state level Webinar "Voice of Survivors' was organized on the 30th of July, 2020 with Survivors of Trafficking to observe the World Day against Trafficking in Persons. The keynote speaker for the event was Priyank Kanoongo, The Chairman, National Commission for Protection for Child Rights (NCPCR), along with speakers from Action Against Trafficking & Sexual Exploitation of Children, India (ATSEC India) and National Action and Coordinating Group against Ending Violence against Women and Children (NACG-EVAC).
- E- Yuva Samvaad Programme was organized and held on the eve of International Youth Day, 12th August, 2020 where we had the Guest of Honour, Mr. Ajay Kumar, Kshetra Sewa Pramukh, Bihar and Jharkhand and other speakers, Mr. Rajesh Tandon, Director, PRIA, New Delhi, Mr. Prashant Karan, Chairperson, ATSEC Jharkhand Chapter and Mr. Sanjay Kumar Mishra, Former Member Jharkhand State Commission for Protection of Child Rights cum Director, BKS were present as the Guest cum Speakers to address the youths participated in the E-Yuva Sanvaad.





- An e-consultation was organized on the 12th of June 2020 on World **Day** Against **Child Labour**to derive an action plan to combat Child Exploitation also known as Khushal Bachpan Kushal Jharkhand which held at the Deputy Commissioner Auditorium, Khunti, Jharkhand. The guests for the consultation were Priyank Kanoongo, The Chairman, National Commission for Protection for Child Rights (NCPCR), Mr. Satyanand Bhokta, Minister, Labor, Employment and Training, Mr. Suraj Kumar, Deputy Commissioner, Mr. Ashutosh Shekhar, Superintendent of Police, Mr. Arvind Kumar Mishra, DDC an representatives from other organizations namely Action Against Trafficking & Sexual Exploitation of Children, India (**ATSEC** India) and National Action and Coordinating Group against Ending Violence against Women and Children (NACG-EVAC).
- A National level Google virtual meeting was held on 8th May 2020 which was chaired by Shri. Priyank Kanoongo, the Chairman, National Commission for Protection for Child Rights (NCPCR). The main issue of the meeting was how to combat human trafficking in the state of Jharkhand as it is one of the top states emerging as the source state for traffickers to make girls fall prey to them where more than 30000 girls have been taken to different metropolitan states for the purpose of trafficking, labour and domestic work and physically and mentally exploited.
- The Jharkhand Voluntary Health Association (JVHA) meeting on 18th February 2020 – JVHA, which is a secular & voluntary association of charitable hospital, health centres in Ranchi, Jharkhand whose goal is to have





a healthy community through community health action, by promoting social justice in the provision & distribution of health care. JVHAs does advocacy, networking and support to communities, grass root CSOs and Govt. Stakeholders by capacity building, resource mobilization, community mobilization etc. JVHA has initiated its work in Jharkhand as a separate wing, along with the support of the NGOs and CSOs working in Jharkhand. The meeting was held to renew memberships and approve new memberships, plan out activities with respect to the existing health issues, formulate a future action plan, and advocate policies in terms of the health issues in Jharkhand.

A two day National Conference on the Prevention of Child Trafficking Post-Lockdown was organized by Bal Kalyan Sangh, Ranchi in collaboration with The National Commission for Protection of Child Rights (NCPCR), District Administration East Singhbhum, A National Action and Coordinating Group against Violence against Women and Children (NACG-EVAC), India and Action Against Trafficking and Sexual Exploitation of Children(ATSEC), Jharkhand was held at Bal Kalyan Ashram, Gobarghusi, Patamda on the 22nd and 23rd of January, 2021 at Gobarghusi, Patamda, Jamshedpur. This National Conference was an inter-agency and inter-professional meeting forum to bring together professionals from the government, civil societies, corporate, health, education, justice and voluntary bodies to address the ongoing risk of increased child trafficking due to the global pandemic and consequently formulate an action plan to combat the menace. The informed participation of professionals from all the areas is necessary and essential in the decision-





making process. The major **objectives of the program were to s**trengthen a strong network amongst the 13 states so as to break the nexus of traffickers thus preventing human trafficking and develop a comprehensive plan of action on the issue of Human Trafficking- Post Covid Lockdown based on the NCPCR document- "Preventing Child Trafficking during Post Lockdown Situation" released on 29.07.2020.

- On 19th February, 2021, 11 trafficking survivors who were rescued and brought back to Ranchi met the Honourable Smt. JobaMajhi, Minister of Social Welfare, Women and Child Development and Tourism, Jharkhand; Shri. D.K. Saxena, Special Secretary, Department of Women, Child Development and Social Security, Jharkhand. Bal Kalyan Sangh's, IRRC and SRC team met the minister and conducted a meeting where a one to one interaction was done with each of the 11 survivors. "Children who want to study will be enrolled by the government in government schools like Kasturba Gandhi Balika Vidyalaya and the others will be given training in various areas under skill development", said Hon. Smt. Joba Majhi. Shri. D. K. Saxena added, "Traffickers and employers who had lured these children from their homes and trafficked them to Delhi are to be tracked and complaints are to be filed against them."
- Health Camp was organized and held for Safai Karamcharis of Bokaro and Gumla City. It focused on Safai Karamchari of Nagar Nigam/Palika. The health camp was held with five specialists namely one physician, one eye specialist, one gynecologist, one dermatologist and one pediatrician in each camp. The free health check-up included blood pressure, sugar test, ECG, eye testing (including the provision of up to 50 nos. of free spectacles) and providing basic medicines free of cost for at least 5 days.
- Shri. Sudhir Kumar, Organisation Minister, Rashtriya Sewa Bharati and Mr. Ajay Kumar, Kshetra Sewa Pramukh, Bihar and Jharkhand visited BalKalyan Ashram, Gobarghusi, Patamda. They met the security guard trainees and communicated with each of them regarding their further life dreams and education.
- · The National Girl Child Day was celebrated in Bal Kalyan Ashram where all

the girls of the security guard training participated; children from the village were also invited to be a part of it. A cultural day with various events like singing, dancing and drama was performed.

- Republic Day was celebrated in all the project offices of Bal Kalyan. The flag was hoisted and the respective team members held small programs in their project areas with the communities to observe the day.
- Women's Day was celebrated in all the project areas of Bal Kalyan Sangh, a large scale program was organized at village Saridkel, a child friendly village of Khunti. The theme of the event organized under the joint aegis of District Administration and Child Welfare Association (BKS) was "Women Leadership: to achieve a uniform future in the world of Covid-19". Torpa MLA Koche Munda was the Guest of Honour for the programme, he spoke on how women have to come forward to protect their rights and that all of us will stand for the protection of their rights. Women gathered there were honoured, along with them women from other project areas were honored and praised for their rightfulness.
- Police training given by Bal Kalyan Sangh in various training centres on issues related to Child Protection, Missing Persons, Women and their safety.
- A consultation meeting was organized by Integrated Rehabilitation-Cum-Resource Centre, Bal Kalyan Sangh in coordination with the National Commission for Protection of Child Rights was held on the 26th of March with the Delhi State Commission for Protection of Child Rights, Child Welfare Committees and District Child Protection Officers, Delhi. The meeting was chaired by Chairperson, National Commission for Protection of Child Rights, Priyank Kanoongo to strengthen the network and partnership amongst all stakeholders for efficient coordination to work towards the best interests of children who have been rescued in Delhi. This meeting was mainly to facilitate the rescue, restoration and rehabilitation of children who have been trafficked from the state of Jharkhand and sold to various people and placement agencies in Delh

SUCCESS STORIES

Case Study-1

Ms. PratimaKumari, who lived 30km far from Ranchi in a placed named Burmu where Pratima lived with her Family. Pratima has one brother and a elder sister in her family. Her Mother passed away when she was very small. After the incident some years later her father decided to remarry. Her brother did not except the decision and left from the home with his wife. After some time her new mother started to manipulate her father for marriage of their elder daughter. By this time Pratima was old enough to understand the situation but she cannot do anything. After marriage of her sister she had to live with her father, step mother and her half sister in the house. Pratima was mentally tortured by her step mother. After completing her Intermediate exams her step mother tried to convince her father to conduct her marriage. After which she heard about the training being conducted by BKS to improve the conditions of vulnerable community. Then she came to BKS Swabhiman Kendra and enrolled herself in the training. After completing her 3 months of house-keeping training she is now successfully placed at BKS Ranchi office at Kamre, Ranchi. She is very happy and living with a dignity and self-respect.

Case Study-2

Name – Santri Kisku Age - 15 years District - Pakur Language - Santhali / Hindi Education - Uptil Class 5

Santri Kisku, a 15 year old girl from the village Nunbada Amdapada, Police Station-Maheshpur, District - Pakur, Jharkhand. Both her parents have passed away. She used to go to school while she was in her village and studied upto Class 5. Other than Santhali language, she speaks and understands Hindi a bit. She has five siblings, out of which three are sisters and two are brothers. Her elder sister too lives in Delhi and works as a domestic help in someone's home. After the death of the parents all siblings lived along with their maternal uncle in his house. The financial condition of the house is very pathetic.

One day while she was in her maternal uncle's home, some guests came over and she knew an aunt amongst them. They said that they will find a good job for her in a house where she will not face any kind of trouble, they spent a lot of time talking to her and in the course of the conversation encouraged her and built her enthusiasm and convinced her to go to Delhi. In course of the counseling, the child told that when she lived at her maternal uncle's house, many boys followed her and they tried to gather all information about her. She said that she had no idea about why they inquired so much about her and she too cluelessly shared all her personal details with them. They laughed and spoke to her every time they crossed paths. She told how she had no idea about what the consequences and the result of all this would be.

One evening she went out for toilet purpose and close to her place was a river where 3-4 boys were already present hiding. Suddenly, all of them surrounded her and tied her hands, feet and eyes and raped her one by one. They then put her in an auto and took her to an unknown place, tied her mouth tightly so that she couldn't shout or even run away. She was very helpless. They kept her with them all night and next morning threw her in front of her house. She turned silent because of the overwhelming fear and shame within her. She started living quietly and was clueless about how to live her life further. She started to live a suffocating life. The miscreants were from around her village itself. The name of the first person was Sanjhala Koda and the names of the two were not known. Days passed by but the child did not open up about this incident to anyone because the boys threatened her saying that if she told any of this to anyone, they would kill her and her family.

Santri, during her first sessions of counseling felt uncomfortable in expressing and sharing her story. The aunt who had come to her maternal uncle's house spoke to her in private to see why she turned so silent and the child shared everything that happened with her. The aunt here took advantage of and persuaded her to go to Delhi. Without understanding her ill-intentions she agreed to go to Delhi. Her aunt soon first got her to Ranchi by train and later sent to New Delhi by flight with another man. This man too raped her. A few days later, she was put to work in someone's house in Delhi itself, where she was supposed to do the household chores. She was beaten and abused by the family where she worked. They treated her very inhumanly. The son of the landlady too physically and sexually assaulted her and when Santri complained to the lady the son instead put all the blame on Santri itself and she would be beaten up again. After all the continuous mistreatment that she

kept receiving for so long she finally looked for a chance and eloped from the home. She was kept in Nari Niketan by Delhi Police and Child Welfare Committee, Delhi. She was then brought back to Ranchi by the BKS IRRC (Integrated Rehabilitation cum Resource Centre) team where she was presented before the Child Welfare Committee on 17.02.2020. The Child Welfare Committee Ranchi, issued an order to be keep the child in Premashraya, Ranchi. She was brought back to Ranchi and produced before Child Welfare Committee, Ranchi. Her stay order was issued for Premashray Ranchi and from there she was rehabilitated home, Santri is now happy and wants to continue to study with her siblings.

Case Study-3

Case Details: This is a case of Shelter, on 24/01/2020, and this case to the CHILDLINE Call Center, Kolkata, to CHILDLINE Dhanbad, come to Kenduadih Police Station (9431706394) on 1098. On receiving the information, the CHILDLINE Team Dhanbad reached Kenduadih police station, the boy was in the police station with his Aunty and Uncle. Child was handed over to CHILDLINE by Kenduadih Police Station. The child was brought to the CHILDLINE Office by CHILDLINE Team Member, then the child was fed by the CHILDLINE, then after some time the child was counseled in which the child told that he does not want to be with the parents, because the child's mother don't loves him. He wants to live with his Uncle and Aunty. Even though he does not want to his study because he used to do some work. Child line Dhanbad contacted his parents and the child was also counseled and ES&G along with them. On 25/01/2020, the child and his parents were presented to the Child Welfare Committee Dhanbad and on the order of CWC, on 27/02/2020, meeting his family and the child was handed over the guardian of the child. And right now, the child is still with his parents and he is happy now.

Case Study-4

Name: Domna Mahato

Age: 14

Language: Sign

Address: Village-Mishribeda, District-Saraikela, Jharkhand

Date of Admission: 09/11/2019

The child was handicapped in the leg and dumb. He used to live with his parents and two sisters in the village. He used to study in his own village. One day the child was travelling along with his friends to Jamshedpur for a trip from where he got lost, he was caught by the Police in Tatanagar Railway Station. He was then produced before the Child Welfare Committee of East Singhbhum and thereafter kept in a home for a few days. However after a few days even after continuous efforts the child's parents and guardians could not be tracked so then the child was sent to Balkuni Boy's Home Chaibasa so that the child can be provided with shelter and also linked to educational amenities. The child was admitted to a school named Mukbadheer School where he went for three months, but then due to the outbreak of the Covid-19 Pandemic the child had to stay back at the shelter home as per the CWC's order as schools were shut down. The child however wanted to return back home, he was looking forward to unite with his parents and his siblings. Balkunj made continuous efforts to track the parents, coordination was maintained with the district administration, the child's details were also updated in the Track the Missing Child Portal, as soon as this was done the child's home and family was traced. Information was given to the Child Welfare Committee on whose directions the guardians of the child were called and the child was handed over to them on the 5th of January, 2021. The child was immensely happy to be back home with his parents and family.
