Let's Act on Our Commitments: End Child Labour

INTRODUCTION

A State Level Multi-Stakeholder Consultation was organized on 12 June 2024 to mark the "World Day against Child Labour 2024" aiming to take forward the ongoing efforts of State Government of Jharkhand towards Prevention and Elimination of Child Labour in State, especially in the Global Mineral Supply Chains including MICA.

The Consultation was organized in Ranchi, Jharkhand, India by International Labour Organization (ILO) through the implementation partner, Bal Kalyan Sangh (BKS) with cooperation of the Department of Labour, Employment, Skill Development and Training, Jharkhand State Children Protection Society, Government of Jharkhand and support from ILO Japan Multi-bilateral Programme. The Honorable Minister of Labour, Employment and Skill development, Government of Jharkhand, Shri Satyanand Bhokta graced the occasion as chief guest.

BACKGROUND

In the heart of India's eastern region lies Jharkhand, a state rich in natural resources including diverse minerals, yet plagued with the pervasive child labour and exploitative labour practices. From the depths of hazardous minefields and mineral processing units to various informal establishments including roadside eateries, child labour has been rampant in the state of Jharkhand. Such children, instead of enjoying their formative years often find themselves toiling under rigorous work conditions and being deprived of basic rights, care, and protection besides denial of educational and developmental opportunities. Despite efforts to curb this grave menace, the persistence of child labour in mineral supply chains reflects deep reality of socio-economic complexities, inadequate enforcement mechanisms, and not-so-effective implementation of child protection programmes.

Recognizing the urgent need to act on the commitments by the stakeholders, in a coordinated and collaborative manner, International Labour Organization (ILO) through the implementation partner, Bal Kalyan Sangh (BKS) with cooperation of the Department of Labour, Employment, Skill Development and Training, Jharkhand State Children Protection Society, Government of Jharkhand and support from ILO Japan Multi-bilateral Programme organized State Level Multi-Stakeholder Dialogue on Elimination of Child Labour in Jharkhand.

The consultation aims to address the challenges faced by stakeholders including the Government, Workers' and Employers' organizations, and the civil society organisations in progressing towards elimination of child labour to meet the Target 8.7 of the United Nations Sustainable Development Goals (SDG) framework. The Consultation deliberated on the issue of Child Labour in general and on Mineral Supply Chains in particular with MICA as immediate focus and explored pathways to Action on the Commitments by all the stakeholders including Academia and Media. The strategy for elimination of child labour in mineral supply chains based on the ILO framework of Decent Work and Fundamental Principles and Rights at Work (FPRW) along with a convergence and collaborative approach with child and family-centric interventions provides for an effective and sustainable model. This model will draw upon earlier experience of ILO globally on integrated approach to address child labour while utilizing the social protection and income generation schemes of the national and state Government



THE EVENT'S THEME, AS ELABORATED UPON BY MR. GIOVANNI SOLEDAD, CHIEF TECHNICAL ADVISOR OF THE INTERNATIONAL LABOUR ORGANIZATION, NEW DELHI, "LET'S ACT ON OUR COMMITMENTS: END CHILD LABOUR."

The 25th anniversary of ILO convention 182 on the worst form of child labour is being celebrated worldwide. This convention, is the only convention to be universally identified, aims to address the issue of the 160 million children still engaged in child labour, with 79 million of them working in hazardous conditions. Two years ago, world leaders gathered in government[1] and declared that the eradication of child labour must be a central focus of economic and social policies. The message being emphasized is the importance of turning this universal commitment into universal action. It is imperative that we act on our commitment to end child labour and ensure the well-being of all children.

Objectives

- Cultivate dialogue and collaboration among diverse stakeholders working on child labour and child protection issues in Jharkhand.
- Build an understanding of the existing functioning of the institutions at the State and District levels and propose pathways for collaborative functioning and synergy.
- Share knowledge, experiences, and best practices in combating child labour and promoting child rights in the hinterlands of Jharkhand.
- Discuss Inter-agency Collaboration and Coordination within the Government and Convergence Strategy to
 accelerate progress towards eliminating child labour in mineral supply chains in Jharkhand with focus on
 mica belt districts of Koderma and Giridih.
- Develop a roadmap incorporating a coordinated action plan with state government in coordination with other stakeholders including the NGOs and Law Enforcement working towards eliminating child labour in Jharkhand.

2 The ILO Declaration on Fundamental Principles and Rights at Work, adopted in 1998 and amended in 2022, is an expression of commitment by governments, employers' and workers' organizations to uphold basic human values - values that are vital to our social and economic lives. It affirms the obligations and commitments that are inherent in membership of the ILO, namely: freedom of association and the effective recognition of the right to collective bargaining, the elimination of all forms of forced or compulsory labour; the effective abolition of child labour; the elimination of discrimination in respect of employment and occupation; and a safe and healthy working environment

DAY LONG SESSIONS

The day started with the inaugural Session where the Hon'ble Minister of Labour, the Secretary, Labour and other senior officials shared their insights and ongoing initiatives of the Government of Jharkhand. There were four technical sessions which were moderated by experts and an experience-sharing session involving Children, child rights advocates, NGOs, officials of Government. These sessions explored possible pathways of coordination and collaboration among stakeholders for prevention and elimination of child labour.

In the inaugural session, key government officials shared insights on ongoing initiatives in Jharkhand to combat child labour, highlighting the importance of social protection schemes and welfare measures for vulnerable families.

PANELIST AND DELEGATES DURING TECHNICAL SESSION



The first technical session emphasized the role of businesses in ensuring child labour-free supply chains, particularly in sectors like small-scale mining. Corporate accountability and ethical labour practices were identified as crucial in addressing the issue.

The second session focused on the establishment of dedicated task forces for increased identification and rescue operations in hazardous sectors like mining, as well as the importance of human rights due diligence processes in monitoring supply chains.

The third session highlighted the effectiveness of awareness campaigns in educating communities on the adverse effects of child labour and the significance of education. Local leaders and influencers were recognized for their role in changing societal attitudes towards the issue.

The final session discussed the challenges of formalizing mica mining and combating illegal operations, emphasizing the need for strengthening and enforcing child labour laws, compliance with labour standards, and improving the outreach of enforcement agencies.

Recommendations included enhancing government through robust programs digital diagnostic monitoring and methodologies, improving collaboration between government and NGO workers, and ensuring a comprehensive last-mile approach to provide remedial support to affected children.

WAY FORWARD



Government of Iharkhand is taking initiatives for labour welfare and towards ending Child Labour and is open to ideas and collaboration for strengthening its Legal Institutional Mechanisms.

Post the Dhibra Policy (Cooperativebased welfare for Mica workers) there is scope for taking forward the implementation of the same at the Districts with the stakeholders and with technical assistance from ILO.

·Jharkhand being mineral rich State, there are other mining operations beyond Mica and labour welfare related challenges where both Policy and implementation related support are needed.

Districts have a complex institutional setup where collaboration among various departments is required, and handholding, training, and the development of monitoring mechanisms are require that areas strengthening through technical and financial support.

Greater levels of government and police authority assistance are needed to make the lives of on-ground NGO workers easier.

A last-mile approach is necessary to ensure that every affected child receives remedial support effective rehabilitation through government initiatives and policies.

Comprehensive policies should be developed and implemented to address the root causes of child labour and to progress towards the effective implementation of ILO Conventions 138 and 182 through concrete action plans.

Multi-jurisdictional enforcement of child protection laws should be strengthened, and specialized training should be provided to enforcement agencies on addressing child labour issues.

 Businesses should be encouraged to implement transparent supply chain practices, particularly in the mineral sector, and develop certification for child labour-free systems products.

Rehabilitation programs for rescued child labourers should be enhanced by providing comprehensive support including education. services. vocational training, and psycho-social support.
